**Application Deadline:** September 15, 2024

**Cancellation:** Full refunds will be given should this event be canceled.

**Festival Time:** 6:00 a.m. – 5:00 p.m. Gates open to the public at 9:00 a.m. The park closes at sundown.

**Set-Up:** Friday, October 4<sup>th</sup>, Noon - 4:00 p.m. Saturday, October 6<sup>th</sup>, 7:00 a.m.- 8:30 a.m. Extra vehicles must move to the parking area by 8:30 a.m. All tents must be secured in the event of wind and foul weather. Spaces will be 12' x 12'. **There will be no electricity available.**

**Take Down:** Clans may begin a “soft” take down at 4:00 p.m. Vehicles may exit the field after 5:00 p.m.

**Festival Insurance:** The festival will always carry festival insurance.

### **Clans:**

- Clans are allowed **one** vehicle to park behind their tent(s). If you are hauling a trailer, please let me know in advance so we can ensure your space has enough room to accommodate your set-up.
- Feel free to sell merchandise related to your Clan; please keep items within your tent.
- If you need to leave early due to an emergency, please let us know so we can safely guide you and your vehicle out of the park.
- You are responsible for setting up, manning, and taking down your tent.
- If you need to cancel, you have until September 1, 2024, to receive a refund.
- If you are a no-show, there will be no refunds.
- Please keep your area clean and return it to the condition in which you received it.

**Legacy Clans:** Clans who took a chance on us our first year will be designated “Legacy Clans.” This means that provided the clan is represented every year moving forward, you will pay a reduced rate for tent spaces, can retain the same space year to year (dependent on the configuration (which can change), and can increase the #number of spaces should you need

them), or request a different site the next year (providing the space has not already been reserved by another Legacy Clan.

I also understand that RCSF&HG does not assume any responsibility or obligation to provide financial assistance or other assistance, including, but not limited to, medical, health, or disability insurance, in the event of injury, illness, death, or property damage.**

2. **Insurance:** I understand the **RCSF&HG** provides group accident or other liability insurance. Any coverage so provided will be governed by the policy language. Except to the extent that it may provide such insurance, **RCSF&HG** does not carry or maintain any health, medical, disability, damage, or other liability insurance coverage for the benefit of its Clans or vendors and expressly disclaims any responsibility or obligation to do so. **AS A CLAN/VENDOR, I AM EXPECTED AND ENCOURAGED BY RCSF&HG TO MAINTAIN MEDICAL, HEALTH, AND ALL OTHER APPLICABLE INSURANCE COVERAGE FOR MY BENEFIT.**

3. **Medical Treatment,** Except as otherwise agreed to by **RCSF&HG** in writing, I at this moment release and forever discharge **RCSF&HG** from any liability claims, demands,
